Immediate Past President – The CPCU Society

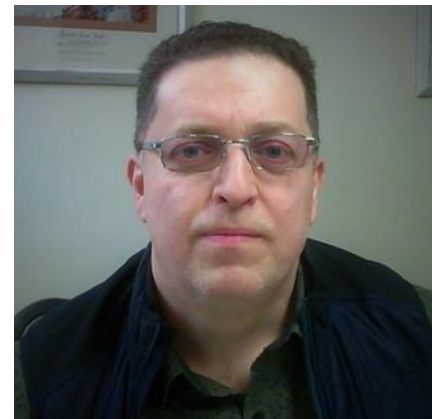
